PUBLIC COMMENT:

Skip Strayer made the Board aware that the numbers that were certified after the reassessment may be inaccurate.

MINUTES:

The minutes of November 1, 2010 were pre-read and approved by motion of Mike Spangler, 2nd by Sharon Hamm, motion carried.

EXPENDITURES & RECEIPTS:

Expenditures dated November 4, 18 and December 2, 2010 and receipts were reviewed and approved by motion of Sharon Hamm, 2nd by Mike Spangler, motion carried.

ROAD DEPARTMENT:

- Preparing for the winter season.

OFFICE ADMINISTRATOR:

- We will be meeting to discuss the quotes for the heating system.
- Phone calls will be made to those that didn't pump in District 2.

ENGINEER:

- The study that was done on Swift Run Road authorizes us to post signs for the weight limit.

An Ordinance will need to be adopted in order to do this.

- Belco is requesting final release of their security. We've inspected the property and everything has been done.

Sharon Hamm moved to approve the release in the amount of \$41,140.00, 2nd by Mike Spangler, motion carried.

APPEARANCES:

Joe Crabill was present because of the setbacks in the Historic Village Overlay District. The setbacks would force him to build a house right along the road.

Wally Davis stated he needed to go before the Zoning Hearing Board to get a variance or present an amendment to the text.

OLD/NEW BUSINESS:

1) Mike Spangler moved to adopt the 2011 Budget, 2nd by Sharon Hamm, motion carried. Mike Spangler moved to adopt Resolution# 2010-08 setting the tax millage on real estate due to the reassessment, 2nd by Sharon Hamm, motion carried.

2) The re-organizational meeting was set for January 3, 2011 at 6:30 p.m. by motion of Sharon Hamm, 2nd by Mike Spangler, motion carried.

3) The Board adopted Ordinance# 2010-04 providing that stormwater should not be designed to discharge into a Commonwealth of Pennsylvania road right of way, and stating the township's policy to not serve as a co-applicant for highway occupancy permits for systems that discharge into such rights of way by motion of Sharon Hamm, 2nd by Mike Spangler, motion carried.

4) Mike Spangler moved to approve the 2011 Animal Control Service Agreement with the SPCA, 2nd by Sharon Hamm, motion carried.

5) Sharon Hamm moved to adopt Resolution# 2010-09 adopting a schedule of fees and charges, 2nd by Mike Spangler, motion carried.

6) The Board authorized advertisement for 2 vacancies on the recreation board.

Skip Strayer stated there is a problem at the end of Hoffman Road at Route 116. The water gets higher than the grates.
